# STRUCTURAL ARMOR WRS Prorated 8 Year Limited Warranty

## **Aquaculture Polyethylene Liner**

Structural Armor WRS warrants to the original retail purchaser that its polyethylene aquaculture liner will not leak due to faulty workmanship that causes seam seal delamination, for up to 8 years from the date of original purchase. Structural Armor WRS's obligation is limited to replace or repair (at our option) any liner found to be defective in workmanship within the limited warranty period. This Limited Warranty specifically excludes any costs, damages or expenses associated with the replacement of the defective liner, or damage to or loss of use of any water, products, building components or other property. Other limitations, disclaimers and exclusions apply.

#### LIMITATIONS

This Limited Warranty is not an insurance policy. Structural Armor WRS shall not be liable for any seam seal delamination failures caused in whole or in part by any of the following:

- If the liner has not been installed, used or maintained in accordance with Structural Armor WRS's written instructions and limitations.
- Use of the liner in any condition other than an aquaculture tank (any other category of use will be excluded under this limited warranty).
- Fire, insects, floods, animals, mishandling, chemicals, poor water chemistry, chemical damage due to the use of salt water systems, chemical stains, shrinkage due to removal of tank water, abrasion due to automatic or manual cleaning, ice damage, microbiological staining and any Act of God.
- Natural disasters, including floods, lightning, hail, earthquakes, gales, hurricanes, or excessive high winds.
- Structural movement, settlement, deflection, failure or movement of any structure, supporting material for the system.
- Tears, punctures, discoloration, cleaning or installation, shipping damage, improper handling, improper installation and storage or any acts
  of improper use, negligence, abuse, misuse or vandalism.
- Lack of proper or adequate design, engineering or construction of the aquaculture tank or system.

### WARRANTY REGISTRATION AND WARRANTY CLAIM PROCEDURE

The original retail purchaser should register their purchase within 10 days from the date of original retail purchase to establish proof of purchase with Structural Armor WRS. Failure to register does not void this limited warranty but, upon any warranty claim, proof of purchase must first be provided to confirm original retail purchase date to the original retail purchaser. Registration can be submitted online at www.structuralarmor.com. In the event of a warranty claim of a defect covered under the provisions of this limited warranty, the original retail purchaser must first notify Structural Armor WRS within ten (10) days of the initial discovery of defect. Upon notice of the warranty claim, Structural Armor will arrange inspection (or request photos of the asserted defect) of the liner to determine if the claimed defect is a covered defect under this limited warranty. If it is determined that the claim is not covered by this limited warranty, Structural Armor WRS repair or replace the liner. In the event of liner replacement, the replacement liner will carry the balance of the original pro-rated limited warranty from the original retail purchase date. Structural Armor WRS reserves the right to collect from the retail purchaser reasonable travel expenses. This limited warranty is extended only to the original retail purchaser and is not transferable. This limited warranty becomes void upon the transfer of ownership.
